Principal's Report

Kelly Jacobson introduced herself and gave overall positive impressions noting the way teachers care about the students, students being responsible in cafeteria, and the number of teachers volunteering for club sponsors. She also mentioned last week's FAST Progress Monitoring and Homecoming activities. PTO will be recognizing students at the end of the first quarter. We currently have 2669 students enrolled.

• Voting of new members
